MEMORANDUM CIRCULAR

TO : ALL HEADS OF DEPARTMENTS, BUREAUS, OFFICES AND AGENCIES OF THE NATIONAL AND LOCAL GOVERNMENTS INCLUDING GOVERNMENT-OWNED OR CONTROLLED CORPORATIONS; STATE COLLEGES AND UNIVERSITIES; EMPLOYEE ASSOCIATIONS OR UNIONS

SUBJECT: PARTICIPATION IN THE NATIONAL CONGRESS OF GOVERNMENT WORKERS

A National Congress of Government Workers will be held on August 24 and 25, 2000 at the Manila Midtown Hotel, Ermita, Manila. A major event in observance of the centennial celebration of the Philippine Civil Service, the Congress has for its theme: *100 Years of Service: Philippine Civil Service at its Best, Mamamayan Muna*. The Congress aims to provide government workers a venue to:

1. Assess the performance of the civil service in the last two decades;
2. Revisit the role of government workers in providing quality service to the public;
3. Gather insights and learning from experiences and innovative practices shared by experts and co-workers; and
4. Draw up meaningful policy recommendations to strengthen the collaboration and partnerships between and among government workers and executives in improving delivery system.

The four major areas of discussion are: Personnel Relations and Welfare Development, Public Accountability, Professionalizing the Bureaucracy, and Best Practices and Innovations.

Considering the significance of this event, heads of agencies are enjoined to send one participant representing the rank and file or employees association or union and one participant representing the management. Participants are authorized to attend the Congress on official business.

The registration fee is Two Thousand Pesos (P2,000.00) per participant, inclusive of lunch, snacks, and materials. Because of limited accommodation, acceptance of participants will be on a first come, first served basis.

Participants may secure the registration forms from any Regional Offices of the Commission as well as its Provincial or Field Offices and submit the same, together with the registration fees, to the nearest Civil Service Regional Office not later than June 30, 2000 or to the Office for Recruitment, Examination and Placement (OREP), Civil Service Commission, Quezon City not later than July 28, 2000.
