MEMORANDUM CIRCULAR

TO : ALL HEADS OF DEPARTMENTS, BUREAUS, OFFICES, AND AGENCIES OF THE NATIONAL GOVERNMENT AND LOCAL GOVERNMENT UNITS, INCLUDING GOVERNMENT-OWNED AND CONTROLLED CORPORATIONS WITH ORIGINAL CHARTERS AND STATE COLLEGES AND UNIVERSITIES

SUBJECT : Additional Category of Positions under CSC Memorandum Circular No. 11, s. 1996

Pursuant to CSC Resolution No. 97-4554 dated December 2, 1997, the Commission has adopted an additional category of positions under CSC MC No. 11, s. 1996 referred to as Category IV. Positions under this Category refer to those positions which, for purposes of permanent appointed thereto, shall require appointees to possess the appropriate licenses and meet the other requirements of the positions as provided under the 1997 Revised Qualification Standards Manual.
