## **MEMORANDUM CIRCULAR**

TO : HEADS OF CONSTITUTIONAL BODIES: DEPARTMENTS.

BUREAUS AND AGENCIES OF THE NATIONAL GOVERNMENT; LOCAL GOVERNMENT UNITS; GOVERNMENT-OWNED AND CONTROLLED CORPORATIONS WITH ORIGINAL CHARTERS;

SUBJECT: Grant of Foreign School Honor Graduate Eligibility to Filipino

Honor Graduates of Bachelor's Degree in Foreign Schools

Pursuant to CSC Resolution No. 1302714\* promulgated on December 17, 2013, the Commission has resolved to grant the Foreign School Honor Graduate Eligibility (FSHGE), as a Civil Service Eligibility, to Filipino citizens who graduated *summa cum laude*, *magna cum laude*, or its equivalent, in their baccalaureate degree earned from a legitimate school/college/university in other countries.

An applicant of FSHGE must meet the following qualification requirements:

- 1. A Filipino citizen who graduated *summa cum laude*, *magna cum laude*, *cum laude*, or its equivalent in his/her baccalaureate degree beginning school year 1972-1973. Applicable Philippine law and rules shall be observed in resolving issues/concerns on citizenship;
- 2. Graduated from a reputable foreign school as verified by the DFA, through the Philippine Foreign Service Posts;
- 3. Has not been found guilty of any crime involving moral turpitude or of infamous, disgraceful or immoral conduct, dishonesty, drunkenness or addiction to drugs;
- 4. Has not been previously found guilty of offenses relative to, or in connection with, the conduct of a civil service examination; and
- 5. Has not been dismissed from the government civil service for cause.

Applications and documentary requirements for the grant of FSHGE should be submitted to the nearest CSC Regional Office (RO) / Field Office (FO) where the applicant is currently based, using CS Form 101-K, December 2013. Evaluation and processing fees shall be paid upon filing and approval of application, respectively.

Honor Graduate Eligibility previously issued to Filipino honor graduates in foreign schools pursuant to PD 907 and CSC Office Memorandum No. 22, s. 1993 shall remain valid.

The FSHGE shall be considered appropriate eligibility for first and second level positions in the government that do not involve practice of profession and are not covered by bar/board/other laws.
