APPROPRIATION ORDINANCE NO. 2023-003

AN ORDINANCE AMENDING THE TITLE AND SECTION 2 OF ORDINANCE NO. 2023-002, ENTITLED: "AN ORDINANCE CREATING SUPPLEMENTAL APPROPRIATION NO. 01 FOR CY 2023 IN THE AMOUNT OF SEVENTY MILLION PESOS (Php70,000,000.00) TO BE TAKEN FROM THE GENERAL FUND TO COVER THE PAYMENT FOR THE OTHER INFRASTRUCTURE ASSETS AND PAYMENT FOR THE OTHER SUPPLIES & MATERIAL EXPENSES OF THE OFFICE OF THE CITY MAYOR, PAYMENT FOR ENVIRONMENT/SANITARY SERVICES OF THE CITY ENVIRONMENT & NATURAL RESOURCES OFFICE AND PAYMENT FOR THE OTHER SUPPLIES & MATERIALS EXPENSES AND PAYMENT FOR THE OTHER MAINTENANCE & OPERATING EXPENSES OF THE STRATEGIC TOURISM DEVELOPMENT ALL OF WHICH ARE UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES OF THE SAID MENTIONED OFFICES OF THE CITY GOVERNMENT OF CAVITE".

WHEREAS, the Committee on Finance, Ways and Means convened a meeting on August 16, 2023 to take up the Proposed Ordinance No. 2023-099 which was tossed back to the committee level last Regular Session dated August 14, 2023 for final amendments;

WHEREAS, during the meeting of the Committee on Finance, Ways and Means Board Member of the Province of Cavite Aidel Paul G. Belamide, Chairman, Committee on Finance, Budget, and Appropriation together with Board Member Kerby I. Salazar discussed the proposed amendments and present the new corrected Statement of Supplemental Appropriation (LBP Form No. 9).



IN VIEW OF THE FOREGOING CONSIDERATIONS, on motion of Sanggunian Member Edmund C. Tirona as principal author, co-sponsored by Sanggunian Members Marrian M. Pinzon, Marc Lawrence DR. Serrano and Eduardo G. Novero, Jr. and duly seconded by Sanggunian Members Maureen E. Lu, A eign Zackrey Nash Victoriano-Aguas, Franklin A. Nuguid, Mark Anthony A. Amparo, Marc Lawrence DR. Serrano, Daryl R. Solis, Eduardo G. Novero, Jr., Renan L. Montoya and Marrian M. Pinzon, this Body

RESOLVED, as it is hereby resolved, to amend the Title and Section 2 of Ordinance No. 2023-002, entitled, "An ordinance creating Supplemental Appropriation No. 1 for CY 2023 in the amount of Seventy Million Pesos (Php70,000,000.00) to be taken from the General Fund to cover the Payment for the Other Infrastructure Assets and Payment for the Other Supplies & Material Expenses of the Office of the City Mayor, Payment for Environment/Sanitary Services of the City Environment & Natural Resources Office and Payment for the Other Supplies & Materials Expenses and Payment for the Other Maintenance & Operating Expenses of the Strategic Tourism Development all of which are under the Maintenance and Other Operating Expenses of the said mentioned offices of the City Government of Cavite", to read as follows:

Be it enacted by the Sangguniang Panlungsod of Cavite City, that:

SECTION 1. The Title of Ordinance No. 2023-002 is hereby amended to read as follows:

"AN ORDINANCE CREATING SUPPLEMENTAL APPROPRIATION NO. 1 FOR CY 2023 IN THE AMOUNT OF SEVENTY MILLION PESOS (Php70,000,000.00) TO BE TAKEN FROM THE GENERAL FUND TO COVER THE ADDITIONAL APPROPRIATION FOR ADMINISTRATIVE SUPPORT SERVICES OF THE OFFICE OF THE CITY MAYOR UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES AND ADDITIONAL APPROPRIATION FOR THE CONSTRUCTION OF PUBLIC FACILITIES OF THE OFFICE OF THE CITY MAYOR UNDER CAPITAL OUTLAY, ADDITIONAL APPROPRIATION FOR SOLID WASTE MANAGEMENT PROGRAM UNDER SPECIAL PURPOSE APPROPRIATIONS, APPROPRIATION FOR CONDUCT OF CAVITE CITY CULTURE AND ARTS FESTIVAL, APPROPRIATION FOR CONDUCT OF NAVIDAD CAVITE CITY CHRISTMAS FESTIVAL, APPROPRIATION FOR CONDUCT OF VARIOUS COMMEMORATION AND CELEBRATION (VIRTUAL) AND APPROPRIATION FOR CONDUCT OF VARIOUS CULTURAL EVENTS OF THE STRATEGIC TOURISM DEVELOPMENT UNDER SPECIAL PURPOSE APPROPRIATIONS OF THE CITY GOVERNMENT OF CAVITE".

SECTION 2. Section 2 of Ordinance No. 2023-002 is hereby also amended to read as follows:

"That the allocated amount of Seventy Million Pesos (Php70,000,000.00) shall cover the Additional Appropriation for Administrative Support Services of the Office of the City Mayor under the Maintenance and Other Operating Expenses and Additional Appropriation for the Construction of Public Facilities of the Office of the City Mayor under Capital Outlay, Additional Appropriation for Solid Waste Management Program under the Special Purpose Appropriations, Appropriation for Conduct of Cavite City Culture and Arts Festival, Appropriation for Conduct of NAVIDAD Cavite City Christmas Festival, Appropriation for Conduct of various Commemoration and Celebration (virtual) and Appropriation for Conduct of various Cultural Events of the Strategic Tourism Development under Special Purpose Appropriations of the City Government of Cavite, enumerated as follows:




