GENERAL ORDINANCE NO. 2023-3392

AN ORDINANCE AMENDING THE TITLE AND SECTION 1 – EXTENSION OF THE PUBLIC MARKET, OF ORDINANCE NO. 2010-3304, AS AMENDED BY ORDINANCE NO. 2022-3379, OTHERWISE KNOWN AS “AN ORDINANCE DECLARING THE MARCOS VALENTIN ST. AND PORTION OF THE MINI-PARK LOCATED AT P. BURGOS ST. IN SAMONTE PARK, CAVITE CITY AS AN EXTENSION OF THE PUBLIC MARKET FROM SEPTEMBER 1 TO DECEMBER 15 OF EVERY YEAR IN CONNECTION WITH THE CELEBRATION OF THE CAVITE CITY FIESTA AND AUTHORIZING THE CITY TREASURER TO COLLECT THE CORRESPONDING FEES AND FURTHER PROVIDING PENALTIES FOR VIOLATION THEREOF.”

RESOLVED, as it is hereby resolved, to amend the Title and Section 1 – Extension of the Public Market, of Ordinance No. 2010-3304, as amended by Ordinance No. 2022-3379, otherwise known as “An ordinance declaring the Marcos Valentine St. and portion of the Mini-Park located at P. Burgos St. in Samonte Park, Cavite City as an extension of the Public Market from September 1 to December 15 of every year in connection with the celebration of the Cavite City Fiesta and authorizing the City Treasurer to collect the corresponding fees and further providing penalties for violation thereof”, to read as follows:

Be it enacted by the Sangguniang Panlungsod of Cavite City, that:

SECTION 1. The Title of City Ordinance No. 2010-3304, as amended by City Ordinance No. 2022-3379 is hereby amended to read as follows:

“AN ORDINANCE DECLARING THE MARCOS VALENTIN ST., PORTION OF THE MINI-PARK LOCATED AT P. BURGOS ST. IN SAMONTE PARK, AND PLAZA SOLEDAD, CAVITE CITY AS AN EXTENSION OF THE PUBLIC MARKET FROM SEPTEMBER 1 TO DECEMBER 15 OF EVERY YEAR IN CONNECTION WITH THE CELEBRATION OF THE CAVITE CITY FIESTA AND AUTHORIZING THE CITY TREASURER TO COLLECT THE CORRESPONDING FEES AND FURTHER PROVIDING PENALTIES FOR VIOLATION THEREOF.”

SECTION 2. Section 1 of City Ordinance No. 2010-3304, as amended by City Ordinance No. 2022-3379 is hereby amended to read as follows:


SECTION 1 – EXTENSION OF THE PUBLIC MARKET – Marcos Valentin St., portion of the mini-park located at P. Burgos St. in Samonte Park, and Plaza Soledad, Cavite City are hereby declared as an extension of the Public Market from September 1 to December 31 of every year in connection with the celebration of the Cavite Fiesta, its founding anniversary, as well as the yuletide season.

SECTION 3. All ordinances, rules, orders and regulations or parts thereof contrary to or inconsistent with any of the provisions of this ordinance are hereby repealed.


SECTION 4. This ordinance shall take effect in full and immediately upon its approval unless otherwise suspended by the proper authorities.


