GENERAL ORDINANCE NO. 2023-3389

AN ORDINANCE RETITLING THE POSITION OF PLANTILLA CASUAL CLERK WITH SALARY GRADE 3, SEQUENCE NO. 39 UNDER THE OFFICE OF THE VICE MAYOR OF THE CITY OF CAVITE.

WHEREAS, on April 17, 2023 Honorable Vice-Mayor Raleigh Grepo Rusit wrote a letter to City Government Department Head I, Human Resource Management Office (HRMO) Ms. Mary Jun K. Villareal requesting for the qualification standards relative to the retitling of Plantilla Casual Clerk Position to Casual Utility Worker Position under the Office of the Vice-Mayor;

WHEREAS, on April 18, 2023 Ms. Mary Jun K. Villareal endorsed to the Honorable Vice-Mayor and Presiding Officer Raleigh Grepo Rusit his

letter request for the enactment of a Sangguniang Panlungsod ordinance retitling the position of Plantilla Casual Clerk to Plantilla Casual Utility Worker;
