GENERAL ORDINANCE NO. 2023-3391

AN ORDINANCE AMENDING SECTION 193 - TABLE OF FARE RATE (OPERATORS/OWNERS, TRICYCLE DRIVERS) PARAGRAPHS (a) AND (b) OF ARTICLE VII, AS AMENDED BY ORDINANCE NO. 2015-3426, ENTITLED: "AN ORDINANCE AMENDING SECTION 176 (DEMAND NOTICE OF RENEWAL) AND SECTION 193 (TABLE OF FARE RATE) OF ARTICLE VII, CHAPTER V OF ORDINANCE NO. 3077, SERIES OF 2005 OTHERWISE KNOWN AS "THE NEW CAVITE CITY TRAFFIC CODE."

On motion of Sanggunian Member Eduardo G. Novero, Jr. as principal author, co-sponsored by Sanggunian Members Maureen E. Lu, Edmund C. Tirona and Mark Anthony A. Amparo and duly seconded by Sanggunian Members Maureen E. Lu, Aeign Zackrey Nash Victoriano-Aguas, Marc Lawrence DR. Serrano, Mark Anthony A. Amparo, Edmund C. Tirona and Renan L. Montoya, this Body

RESOLVED, as it is hereby resolved, to amend Section 193 - Table of Fare Rate (Operators/Owners, Tricycle Drivers) Paragraphs (a) and (b) of Article VII, as amended by Ordinance No. 2015-3426, entitled: "An ordinance amending Section 176 (Demand Notice of Renewal) and Section 193 (Table of Fare Rate) of Article VII, Chapter V of Ordinance No. 3077, Series of 2005 otherwise known as "The New Cavite City Traffic Code", to read as follows:

Be it enacted by the Sangguniang Panlungsod of Cavite City, that:

SECTION 1. Section 193 of Ordinance No. 2015-3426 is hereby amended to read as follows:

FROM:

- Fifteen Pesos (Php15.00) for each passenger. In case of big cargoes OCCUPYING a portion of the sidecar and big cargoes LOADED at the back compartment, an ADDITIONAL amount of Ten Pesos (Php10.00) per cargo shall be collected.

- b) Night Operations from 10:00 PM to 4:00 AM inside Cavite City only-Minimum Fare of TWENTY Pesos (Php20.00) for each passenger or a maximum fare of SIXTY Pesos (Php60.00) for all passengers, or as may be mutually agreed upon by both parties.


TO:

- a) **Twenty Pesos (Php20.00)** for each passenger. In case of big cargoes OCCUPYING a portion of the sidecar and big cargoes LOADED at the back compartment, an ADDITIONAL amount of **Fifteen Pesos (Php15.00)** per cargo shall be collected.
- b) Night Operations from 10:00 PM to 4:00 AM inside Cavite City only-Minimum Fare of **TWENTY-FIVE (Php25.00)** for each passenger or a maximum fare of **SEVENTY-FIVE (Php75.00)** for all passengers, or as may be mutually agreed upon by both parties.

SECTION 2. This ordinance shall take effect upon its approval.
